It is fully understood that the District is not responsible, nor does the District assume liability, for any injuries or losses resulting from use of this non-District sponsored transportation.

Assumption of Risk

The undersigned Student or Parent hereby acknowledges, agrees, warrants, and covenants that (1) Student or Parent voluntarily and of his or her own free will, desires to provide for Student’s transportation to or from the Activity; (2) there may be significant risks, including without limitation, the risk of serious personal or bodily injury, death, economic or emotional loss, or property damages, associated with Student’s use of non-District sponsored transportation to travel to and from the Activity; and (3) Student or Parent on behalf of themselves and their respective heirs, administrators, personal representatives, and successors, willingly and freely assumes such risks on behalf of Student.

Waiver/Release/Agreement Not to Sue

To the fullest extent permitted by law, the undersigned Student or Parent for themselves and their respective heirs, administrators, personal representatives and successors, hereby voluntarily and of his/her/their own free will waives the right to bring any claim, demand, action, suit, or cause of action against, and hereby releases, discharges, holds harmless, and promises not to sue, the District for any and all claims, demands, actions, suits, damages, remedies, or causes of action for personal injury, wrongful death, psychological injury, illness, emotional distress, and/or property damage resulting from, arising out of, or related to, Student’s use of non-District sponsored transportation to travel to and from the Activity.

Indemnity

The undersigned Student or Parent further agrees to indemnify and hold harmless the District from any and all claims, demands, actions, suits, causes of action, costs, expenses, damages and liabilities, including attorneys’ fees that may be brought as a result of Student’s use of non-District sponsored transportation to or from the Activity.

I CERTIFY THAT I HAVE READ AND UNDERSTAND THE LEGAL CONSEQUENCES OF SIGNING THIS STUDENT VOLUNTARY TRANSPORTATION AGREEMENT (“AGREEMENT”), INCLUDING (1) RELEASING THE DISTRICT FROM LIABILITY AND PROMISING NOT TO SUE THE DISTRICT; (2) ASSUMING THE RISK OF INJURY OR DEATH ASSOCIATED WITH AND BY STUDENT’S USE OF NON-DISTRICT SPONSORED TRANSPORTATION TO AND FROM THE ACTIVITY; AND (3) AGREEING TO INDEMNIFY, DEFEND AND HOLD HARMLESS THE DISTRICT. I FURTHER UNDERSTAND THAT THIS AGREEMENT IS WRITTEN TO BE AS BROAD AND INCLUSIVE AS LEGALLY PERMITTED BY THE STATE OF CALIFORNIA. I AGREE, WARRANT, AND COVENANT THAT IF ANY PORTION OF THIS AGREEMENT IS HELD INVALID OR UNENFORCEABLE, I SHALL CONTINUE TO BE BOUND BY THE REMAINING TERMS.
