## *Meeting of October 19, 2022*

### **Consent Items - Board unanimously approved the Consent Calendar Items (5,0)**

- **The Board approved California School Boards Association (CSBA) and Carmel Unified School District Board Quarterly Policy Updates:** Members of the Board Policy Review Committee met on October 3rd and reviewed in detail the policies brought forward during tonight's meeting.

### **Action/Discussion/Information Items**

- **The Board conducted a public hearing to review draft maps and provide input regarding the establishment of trustee areas:** The District is finalizing the process of establishing trustee areas and changing the method of electing members of the Board to ensure compliance with the California Voting Rights Act of 2001. This fifth and final public hearing was held for members of the public to have the opportunity to provide input regarding the draft maps and the proposed sequence of elections. After the public hearing, the Board received [a presentation from the demographers](#). Following the presentation, the Board discussed the draft maps and selected [Map 9B](#) (*draft map linked - trustee areas must be re-numbered*) as the final map. - **The Board adopted Resolution #22-17 Adopting Trustee Area Boundary Map and Election Sequence for Election of Members of the Board of Education; and Submitting Proposal to the County Committee on School District Organization to Establish By-Trustee Area Elections:** To advance this process, the Board adopted the resolution to adopt the trustee area boundary map (CUSD [Map 9B](#) (*draft map linked - trustee areas must be re-numbered*)) and election sequence to be implemented beginning with the 2024 Board elections. The resolution directs District staff to submit the map to the Monterey County Committee on School District Organization for final approval at a special meeting to be held on November 16, 2022 at 5 p.m. in Carmel Middle School Library.
- **The Board approved [Tentative Agreements between the Association of Carmel Teachers \(ACT\) and the Carmel Unified School District \(CUSD\) for 2022-23](#) and between [Classified School Employees Association \(CSEA\), Chapter 190 and the Carmel Unified School District \(CUSD\) for 2022-23 and 2023-24](#) and the associated AB 1200 Public Disclosure Documents:** After negotiations following the Interest Based Bargaining (IBB) process, tentative agreements have been made with both bargaining units. Staff presented a review of the agreements.
- **The Board approved the 2022-2023 Salary Schedules for Certificated, Classified, and Unrepresented Employees:** The 2022-2023 salary schedules have been updated based upon approval of the tentative agreements with CSEA and ACT noted above.
- **The Board received a [presentation on Athletics and Activities Implications Related to Late Start](#):** Carmel High School Staff shared a presentation on various activities at Carmel High School and the implications they may have on start times.
- **The Board received a [presentation on Potential Staffing Considerations and Negotiations Related to Late Start Options](#):** Staff presented an overview of potential staffing considerations and negotiations while considering late start options.
