Dear Ms. Dillard:

On behalf of our client, Carmel Unified School District ("District"), this letter supplements our correspondence, dated April 6, 2022 and June 7, 2022, in response to your recent request for records (#2122-31) under the California Public Records Act ("CPRA"), with respect to your CPRA Request Category 1 and Category 2:

- CPRA Request Category 1: "Any 'records' which include a wide variety of documents and other materials (including print, photographic, and electronic formats such as e-mails) that were created or obtained by the organization that sheds light on the purpose of creating the website: <https://www.carmelunified.org/Page/6026>
  - Window of inquiry should include from October 2021 – through this request, March 27th 2022.
  - "Records" should include e-mails that contain "CEQA", "stadium lights", "pool", "performing art center or theater" "California Public Records Act" and or "Dillard".
  - Please include any reference to the website, the url and/or specific individuals including the contact on the page: Jessica Hull."
- CPRA Request Category 2: "As part of the California Public Records Act (CPRA) (REQUEST 2), please provide all CPRA requests and responses from 2008 and forward to the current date of 2022. That time window should be inclusive of all the years (2008-2022) and key words should include any public inquiries including key words that surround the passed #08-08 resolution of the pool, pool lights and performing art center/theater."

Notwithstanding the objections raised in our previous correspondence, based on the District's understanding of your request as set forth in our April 6, 2022 and June 7, 2022 letters, the District has determined that it has disclosable and responsive records to your request, as follows:

- Emails from between October 2021 through March 27, 2022 that were sent from or to Jessica Hull, Director of Communications and Community Relations, that contain the following key terms: "https://www.carmelunified.org/Page/6026", "CEQA", "stadium lights", "pool", "performing art center or theater", "California Public Records Act", "CPRA website", "CPRA webpage", and/or "Dillard".
- CPRA requests received by the District and the related responses from January 1, 2008 to April 6, 2022, that pertain to or reference the New Pool Project (2006) and New Theater Building Project (2009) and the process undergone for both projects under CEQA, including Board Resolution #08-08 (dated February 11, 2008).

As you know, Board Resolution #08-08 was previously provided to you by the District on March 21, 2022 in response to your February 27, 2022 CPRA Request #2122-22a+b. With respect to the other responsive and disclosable records described above, the District is in the process of making these records available to you electronically via a sharefile link, which is anticipated to be ready by early next week. Once available, the sharefile link will be sent to you from our office via email ([dillardfran@gmail.com](mailto:dillardfran@gmail.com)), and you may download the requested records directly from the link.

Given the volume of records requested from a 14-year time span, the records produced to you in the forthcoming sharefile link constitute the first batch of responsive records. We anticipate that we will be able to provide you with a status update with respect to the subsequent production by the end of next week.

All objections raised in our April 6, 2022 and June 7, 2022 correspondence, also apply to this supplemental response and are fully incorporated herein.
