Over the course of the previous year, CUSD has meaningfully consulted with its stakeholder groups around the development of the Expanded Learning Opportunities Grant Plan (ELO) and the Local Control Accountability Plan (LCAP) through a multi-faceted approach.

Broad site based stakeholder committees were established to examine data, identify current needs and/or areas of improvement, and to recommend actions for meeting those needs. Those committees came together at the district level to discuss current realities, and to prioritize actions and services that would help to meet the needs of our students. Surveys were also sent out to stakeholder groups in order to gauge progress and to gather input for the purposes of informing our planning. Staff and bargaining units were consulted through meetings, and administration work continuously throughout the year to understand the data and process stakeholder input. Additionally the ELO and LCAP went to the School Board for public hearings and approval.

The ESSER III plan has been developed in conjunction with the stakeholder engagement processes and input from the LCAP and ELO plans. There has also been additional engagement of the CUSD community in the form of an ESSER III survey that was sent to families, staff, and students, encompassing all of the required groups, to capture their perspectives and insights around safe in-person learning and supporting students during the continued COVID-19 pandemic. Consultation meetings with bargaining units and parents of English language learners were also held to ensure broad engagement. The input and insights provided by the CUSD community during the process was integral in the development of this plan.

Stakeholder feedback was critical in the development of this ESSER III plan just as it was in development of the LCAP and ELO plans. Based on stakeholder input for the LCAP, ELO, and additional survey feedback, a focus on student mental health and wellness has been prioritized as the most resounding need to support our students relative to the impact of COVID-19 school closures. Our stakeholders have also prioritized keeping schools open to safe in-person instruction since the start of the pandemic. Stakeholder input helped to develop and refine our approach to prevention and mitigation strategies to continuously and safely operate schools for in-person learning. The community is supportive of strategies such as contact tracing to ensure health and safety and minimize spread of COVID-19 and resulting loss of school time. These community priorities are reflected in this plan, and our community has indicated a 90% satisfaction rate with the district's planned strategies for the use of ESSER III funding.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;
