Elementary instructional material selection committees include teacher representatives from each grade level and site. Secondary committees include teacher representatives from the department involved in the textbook selection. Site and district administration, as well as instructional coaches, also serve on these committees. For all K-8 instructional materials adoptions, only the most recent State Board of Education approved materials are considered. Publisher representatives from the two top-rated programs make a presentation to the selection committee. Texts are often piloted for a term or full school year as part of the selection process. The selection committee makes a recommendation to our governing board for district approval. All selected instructional materials are aligned with the Curriculum Frameworks adopted by the State Board of Education. Each Fall our governing board holds a public hearing to adopt a resolution of instructional materials sufficiency.

School Facility Conditions and Planned Improvements

Carmelo was built in phases from 1961 to 1966 and a portable classroom was added in 2011. The site has 10 rooms including the portable classroom.

The site has a library, age appropriate play structures for each age group and access to large grass athletic fields.

Carmelo was modernized in 2003/2004, is in good condition and is cleaned daily. It is assigned 1 janitorial staff with additional staff assigned as needed during summer deep cleaning. Repair requests are submitted through the District's work order system. Emergency repair needs are reported directly to the maintenance department.

The site has sufficient space to support both students and staff.

The District uses a preventive maintenance program to continuously inspect and repair facilities.

Carmelo is fenced on all sides and a surveillance camera system covers all access points to the campus. The site has a monitored fire alarm system with smoke detectors in each room.

All roofs were replaced in 2019 and 2020 using deferred maintenance funds. The site will be painted in 2022 using funds from the routine restricted maintenance account. The local wastewater district is planning a sewer extension project which will allow the site to remove its septic tank.

3-4 Additional buildings/classrooms will be built to accommodate expanded universal Transitional Kindergarten.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;

Carmelo has a comprehensive school safety plan that is amended every year which includes monthly safety drills, Site emergency plan, safety and security assessment and goals, and an evacuation plan. The staff has been trained on ALICE as well. The comprehensive school safety plan was last reviewed October 2022.
