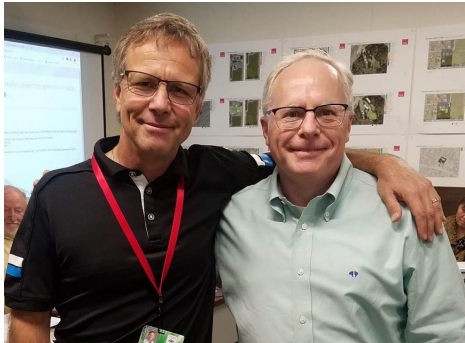

## SPECIAL REPORTS AND APPEARANCES

**School Services of California (SSC) Special Education Study**  
SSC presented their findings after conducting a review of our special education programming and staffing.

### LPA Facilities Master Plan Presentation

LPA presented the final master facilities plan to the Board and discussed what possible next steps could be for the Board.

## ACTION/DISCUSSION/INFORMATION ITEMS

### Election of Board Clerk

The Board elected Sara Hinds as the new Board Clerk to replace Rita Patel, who recently resigned her position as a Board Member and Clerk.

### ACT Discussion on Bereavement Leave and Negotiations

ACT president Bill Schrier shared his views on the recent negotiations process and related request regarding Bereavement Leave for non-family members.

**The 2019-20 Update to the 2017-20 Local Control Accountability Plan (LCAP) and District Goals** were approved by the Board.

**The 2019-2020 Budget Adoption and Excess Reserves** was presented and approved by the Board.

**Contracts for ACT (Carmel Teachers) and CSEA (CA School Employees Association - classified staff)** Each contract had a public hearing and then all were adopted by the Board.

### Salary Schedules for 2019-2020

All salary schedules for next year were approved by the Board.

### Assistant Principal - Carmel Middle School - Jen Kasper

Employment contract was approved naming Jen Kasper as the next assistant principal for Carmel Middle School.

### Superintendent's Contract

The Board approved a third amendment to the Superintendent's original contract.

## New and updated job descriptions

The Board approved updates and/or new job descriptions for: athletic director, theater technician/substitute theater manager, and CVHS/Adult School secretary to the principal.

## 2020-2021 School Calendar

The CUSD school year calendar for 2020-2021 was approved by the Board.

## Public Hearing - Monitoring Student's Technology/Social Media

A required public hearing was held as the district considers using tools to monitor student technology and social media use related to school and student safety.

## Business Office Resolutions

The Board approved resolutions to authorize agents for the district to sign orders and to enter into contracts, subject to board authorization. Cal Card limits and authorizations were also approved.

## Process for Appointment of New Board Member

Board approved a process and timeline for appointing a provisional new board member to fill the current vacancy created by Rita Patel's resignation and to fill board liaison and/or committee memberships for same.
